



# INSTRUCTIONS TO VOTER

TO VOTE YOU MUST COMPLETELY BLACKEN THE OVAL (●) TO THE LEFT OF YOUR CHOICE. An oval (●) blackened to the left of the name of any candidate indicates a vote for that candidate  
 To cast a write-in vote for a person whose name is not on the ballot, you must blacken the oval (●) to the left of the line provided, and write or print the name in the blank space provided for that purpose.  
 To vote in FAVOR of a Question, fill in the oval (●) to the left of the word YES. To vote AGAINST a Question, fill in the oval (●) to the left of the word NO.  
 Use only black ink pen.  
 If you make a mistake DO NOT ERASE. Ask for a new ballot.

**Please be sure to vote for each & every marked candidate! Check both sides of the ballot!!**
